5. Customers must both (i) purchase an eligible product (see section 7-9) from their authorised participating John Deere dealer, and (ii) follow through to completion of the invoice to redeem the Gift defined below in section 7-9.
6. The Promotion commences on 00h01 (AEST) 14 April 2025 and concludes at 23h59 (AEST) 13 July 2025 (the “Promotion Period”). To redeem the Gift, customer must purchase 1 (one) 20 L or more of Plus-50™ II genuine lubricants.
